<u>15/06245/FUL</u>	Windy Ridge Marlow Road Lane End	Demolition of the existing bungalow and the erection of a pair of two storey 3 x bed semi-detached dwellings each with an array of solar panels to the roof slope & creation of a new access from Marlow Road (alternative scheme to 14/05724/FUL)
